## CONDITIONS FOR THE LEASE OF LAND AND CONSTRUCTION OF TOMBSTONE / HEADSTONE

1. The size of the tombstone / headstone shall not exceed

Thickness - 3 inches Width - 2 Feet Height - 3 Feet

- 2. The approved registration number must be engraved / embedded on the tombstone / headstone and must be clearly visible.
- 3. No fencing or planting of trees is allowed around the tombstone / headstone. The Board encourages offerings of fruits and flowers only at the tombstone.
- 4. The land for construction of the tombstone / headstone is leased for a period of 30 years from the date of payment of RM2,500.00. Upon expiry the lease must be renewed and the lease shall be for the next 30 years for a sum that will be fixed by the Board. The payment for the lease shall be paid by way of Cheque, Bank Draft and or Postal / Money Order made under -

If there is any infringement in the size of the tombstone / headstone the applicant, our contractor shall undertake to carry out remedial works and or removed the tombstone / headstone in order to comply with the conditions imposed. In the event of a failure to do so, the Hindu Endowments Board reserves the right to carry out such works and seek reimbursement for all the expenses incurred.
- 7. Any officer of the Hindu Endowments Board may inspect the works being carried out during construction.
